MANUAL - I

Functions and Duties:

The Registration Branch is one of the Administrative Organisation in the Administration of the Sub Divisional Officer (Civil), Sohra. The function of the Branch is more regulatory and statutory and functions under the control of the Sub Divisional Officer (C), Sohra.

- 1. The Registration Branch is responsible for registration of Documents like Mining Lease, Deed of Declaration, Gift Deed, Sale Deed and many other as per Regulation under the Indian Registration Act, 1908.
- 2. The Registration Branch is also responsible for the Registration of Marriage and others as per the regulation Under Section 3 of the Special Marriage Act, 1954 and Under Section 4 of the Meghalaya Compulsory Registration of Marriage Act, 2012. (Act No. 13 of 2012)

Registration branch include in the amalgamated Establishment.

The Sub Divisional Officer (C) is the Sub Registrar / Marriage Officer / Marriage Registrar and is the controlling officer of the Branch. The E.A.C. who is also function as subordinate Officer is responsible for examining all documents related for *Registration*.

- a. Summer Timing -10.00 AM 5.00 PM
- b. Winter Timing -10.00 AM 4.30 PM

MANUAL – 2

Power and Duties of Officers and Employees:

Designation: 1. The Sub Divisional Officer (C), Sohra is also the Sub Registrar / Marriage Officer / Marriage Registrar who is appointed by the Government. He is empowered to delegate subject as per the restriction and condition prescribe by the *Registration Act*, 1908, Special Marriage Act, 1954 and Meghalaya Compulsory Registration Act, 2012.

2. The Extra Assistant Commissioner is appointed by the Government to assist the Sub Registrar / Marriage Officer / Marriage Registrar regarding matter related to Registration and any other work delegated.

<u>Powers:</u> The Power under the Indian Registration Act, 1908, Special Marriage Act, 1954 and Meghalaya compulsory Registration of Marriage Act, 2012 are vested in the Sub Registrar / Marriage Officer / Marriage Registrar who is empowered to delegate subject to the restriction and conditioned prescribed by Rules under the Acts any of his power to any person appointed by the Government and to assist him/her as follows: (a) EAC, (b) Grade III staff, (c) Grade IV staff.

<u>Power Administrative:</u> to oversee the functioning of the Branch under his control including the duties and responsibilities if Subordinate Officers, Staff for Public authority and to exercise the power as may be delegated to him by the *Registration Act*, 1908, Special Marriage Act, 1954 and Meghalaya Compulsory Registration Act, 2012.

Financial – At present none

Others: Examining of all documents related to registration.

There is separate sanction of Grade III & Grade IV staff for Registration Branch. The day to day official works are mostly performed by the Grade III & Grade IV staff under the supervision of the Sub Registrar / Marriage Officer / Marriage Registrar and EAC being the Subordinate Officer.
